# **ZENTRA Project Whitepaper**

## 1. Executive Summary

ZENTRA is a blockchain-based project deployed on the Somnia Network, introducing the ZENTRA token with a maximum supply of 100 million tokens. The project focuses on NFT-based access for token farming, community-driven growth, and sustainable ecosystem development. ZENTRA's vision is to create a reliable platform where NFT holders can participate in reward farming while contributing to the broader Somnia ecosystem.

Planned exchange listings are scheduled for early 2026, positioning ZENTRA as a key utility token with practical use-cases for its community.

### 2. Problem Statement & Solution

### 2.1 Problems in the Current Ecosystem

- Limited utility of NFTs Many NFT projects do not provide tangible benefits beyond collectible value.
- Inefficient reward systems Users are often not fairly incentivized for participating in ecosystem activities.
- Access challenges Engaging with new blockchain projects, especially those involving farming rewards, can be complex for the average user.

#### 2.2 ZENTRA Solutions

- NFT Access System: NFT holders gain exclusive access to token farming rewards.
- **Reward Boosters:** Specialized NFTs increase the amount of farming rewards by 50% or 100%.
- Fair Distribution Mechanisms: Presale and airdrop initiatives ensure equitable allocation of tokens.

• **Somnia Network Support:** Leveraging a secure and efficient blockchain infrastructure for all transactions.
